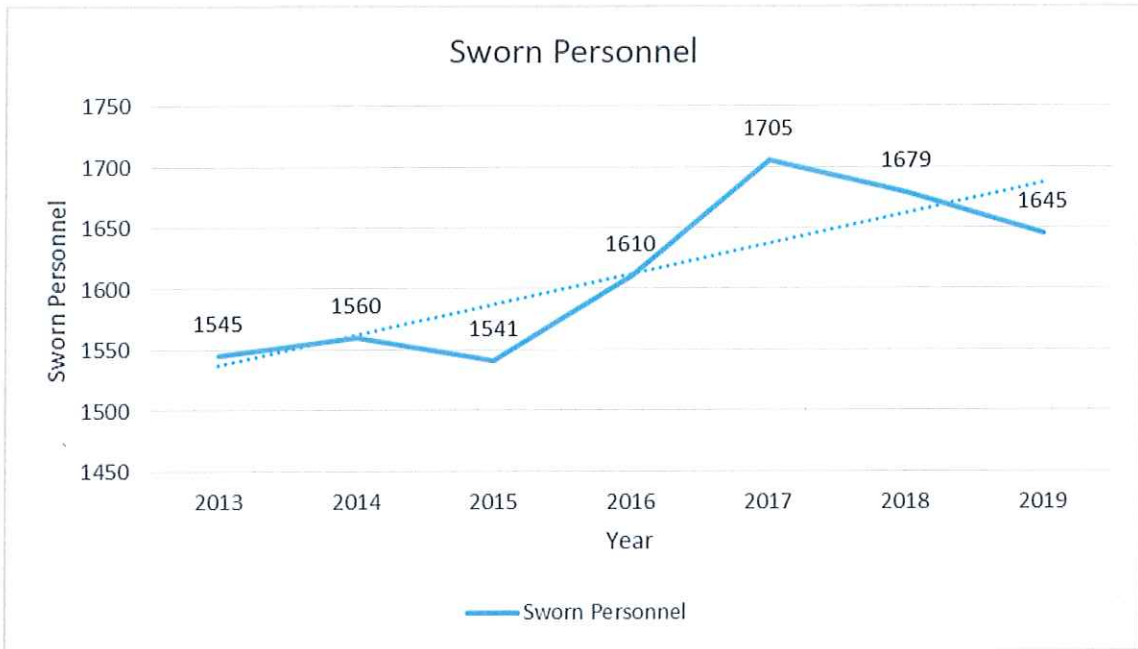

DATA REPORTING PARAMETERS

- Information includes data pulled into the IAPro system as of 01/31/2020.
- Incidents entered into BlueTeam are given a received date based on when the person entered information about the event. The following reports are based on cases with a noted received date between 01/01/2019 and 12/31/2019.
- Use of Force reports are made on all incidents where an officer used force on a citizen (Takedown, Physical Force, Taser, Baton, Impact Weapons, and Deadly Force). The report itself does not mean any administrative violations occurred. If a use of force is flagged for possible violations, it is duplicated into an administrative investigation and the use of force report will be notated with that fact.
- In some cases, reports are entered with incomplete information. Incomplete data is shown in these reports under the label of “No Data”.
- Other unique reporting challenges or interpretation guidelines for individual reports are noted in the explanatory textboxes located throughout the report.
- As with all information collection systems, the quality of data entered affects the quality of data reported.



Use of Force

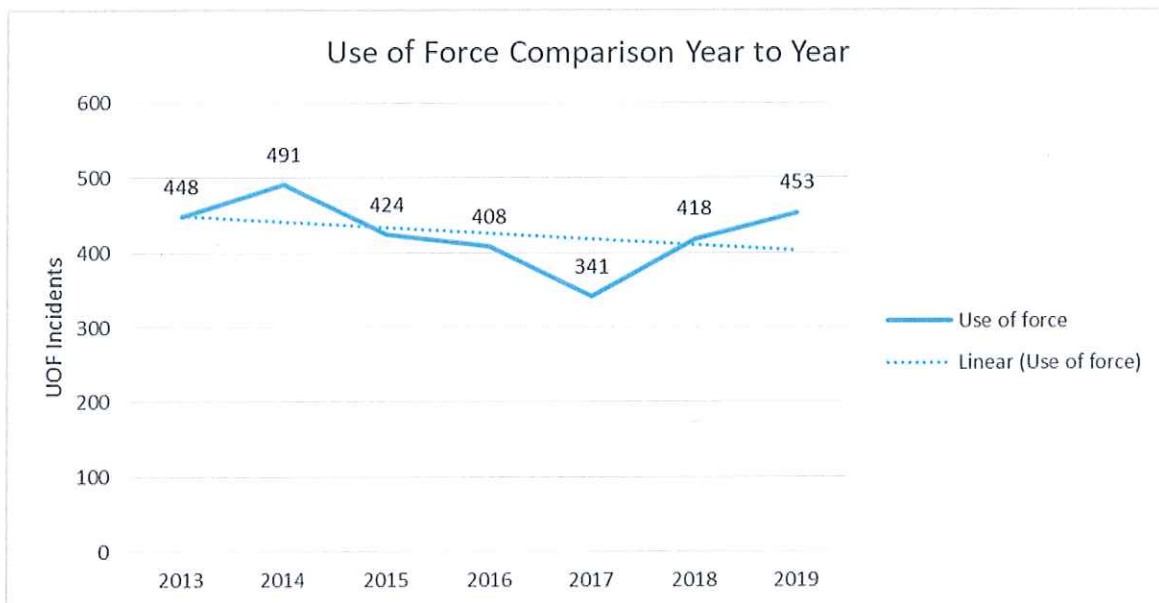
Use of Force Reporting Requirements

The Fort Worth Police Department requires an administrative Use of Force report on all use of force incidents which result in injury to any person, involves the use of a physical control method that includes a strike or the grounding/takedown of a subject, or any use of a weapon to control a subject. The Use of Force Report is reviewed by the Officer's Supervisor, and through the entire chain of command up to the Assistant Chief of Police. The Use of Force is reviewed to ensure the use was appropriate and within the guidelines of department policy and law. If the officer used force inappropriately, a departmental investigation is required and the officer may receive additional training or in some cases discipline up to and including termination from employment.

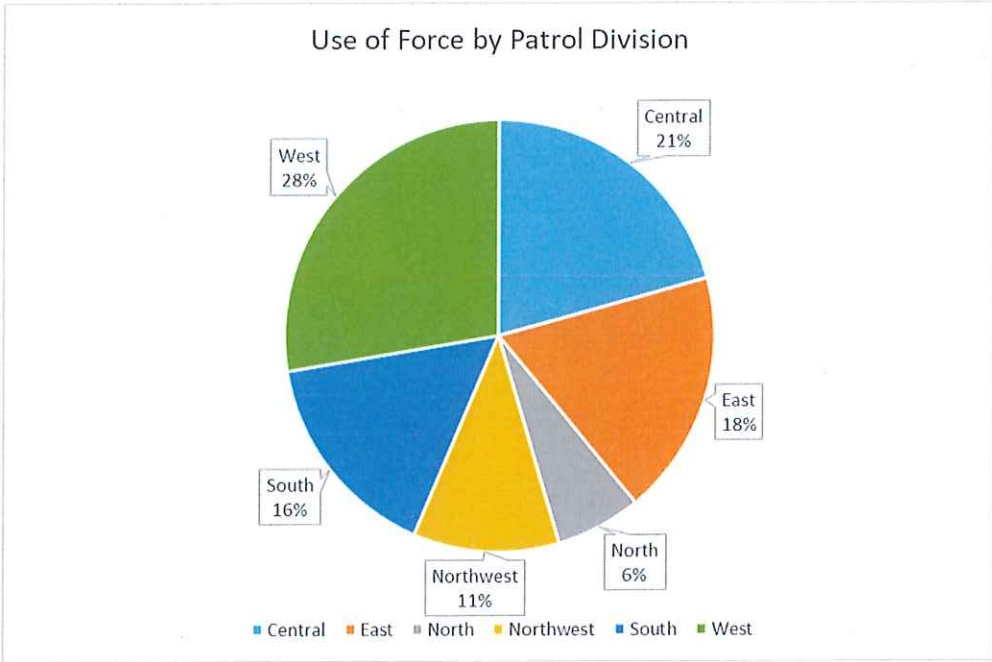
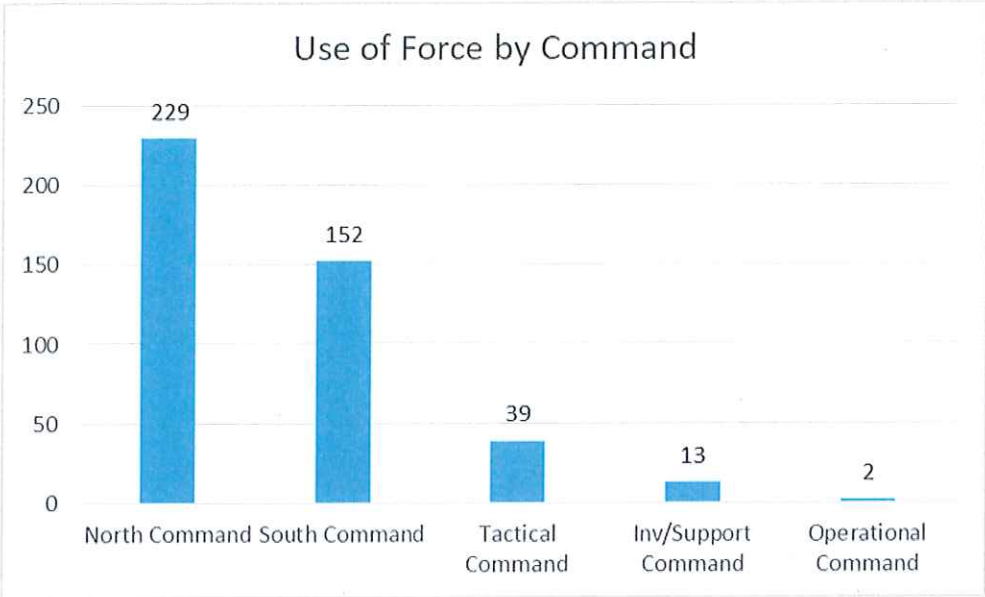
Use of Force Comparison Year to Year

During 2019, there were 453 reported Uses of Force compared to 418 during 2018. This represents an 8% percent increase.

- The total number of UOF incidents for 2019 is 453.
- The total number of officers involved in at least one UOF incident in 2019 is 725 (Involved Officer or Assist Officer to the UOF).
- The total number of citizens involved in a UOF for 2019 is 453.
- The total UOF incidents in 2019 increased 8% compared to 2018.
- Use of Force data used for this report is based on 435 reviewed UOF incidents. 18 UOF incidents were still under review by the chain of command as of the data collection date (01/31/2020).



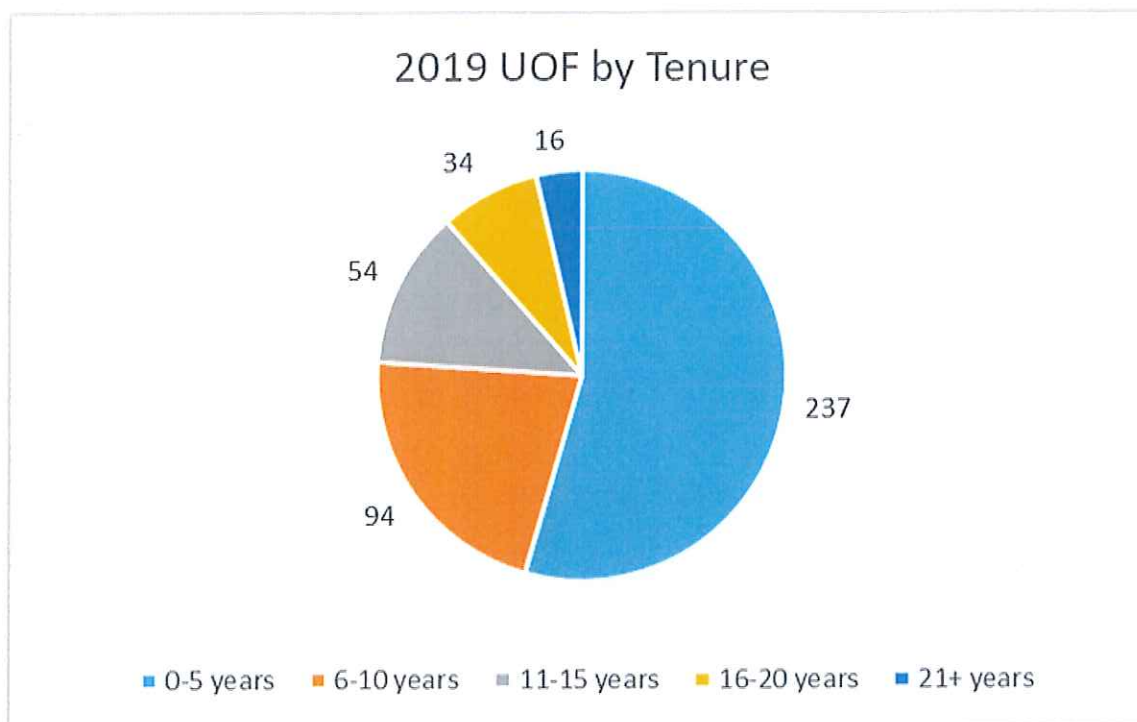
* The **2019 UOF by Command** charts show incidents of UOF that occurred in 2019 that are completed 435.

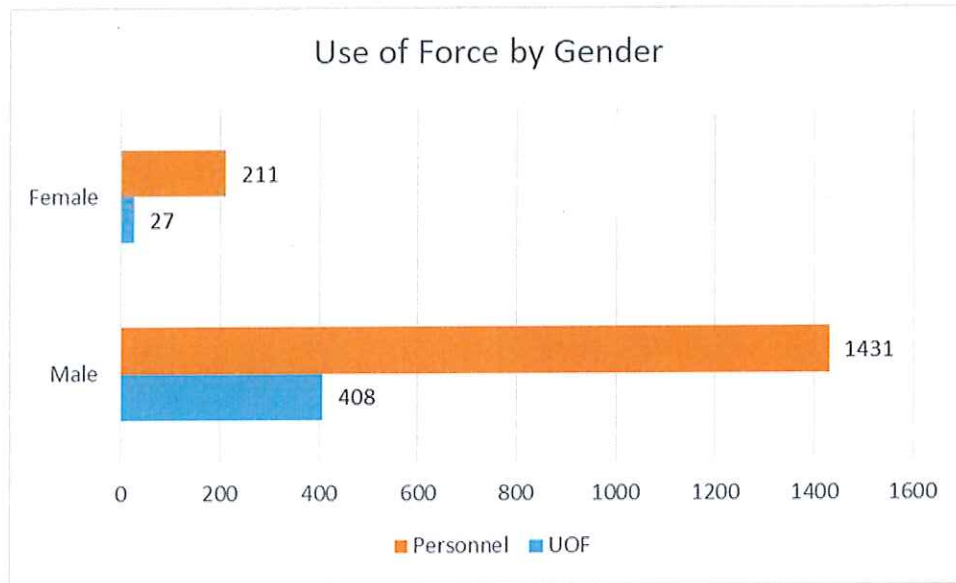

The *UOF by Officer Tenure* chart shows the tenure breakdown for officers that used force and the percent of the total that each tenure group represents.



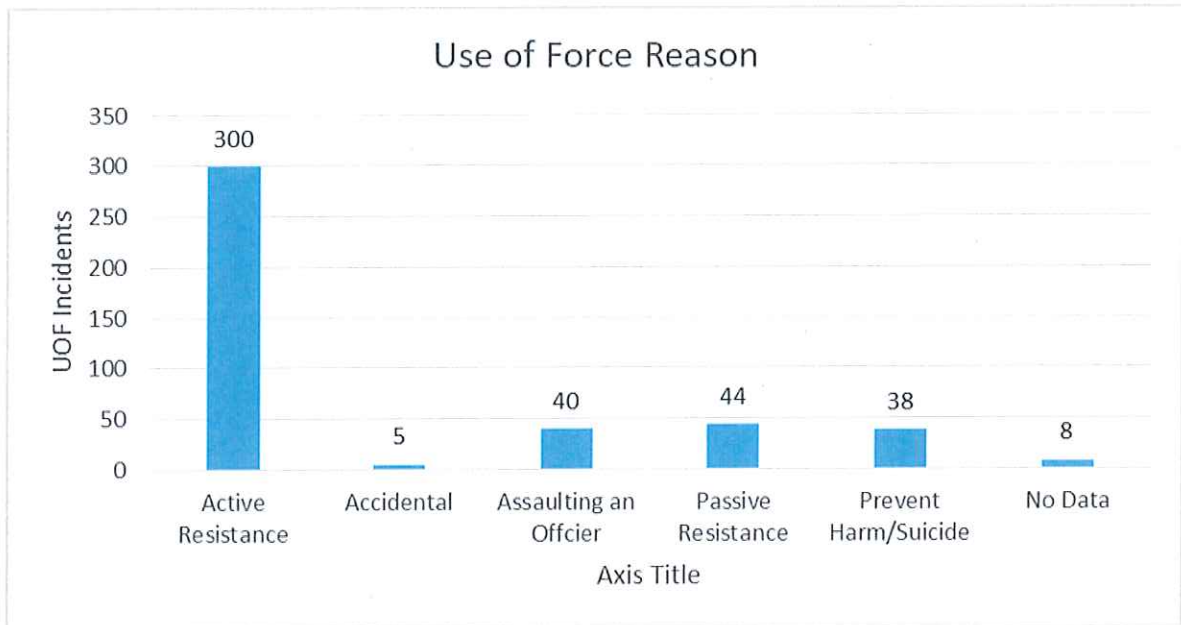

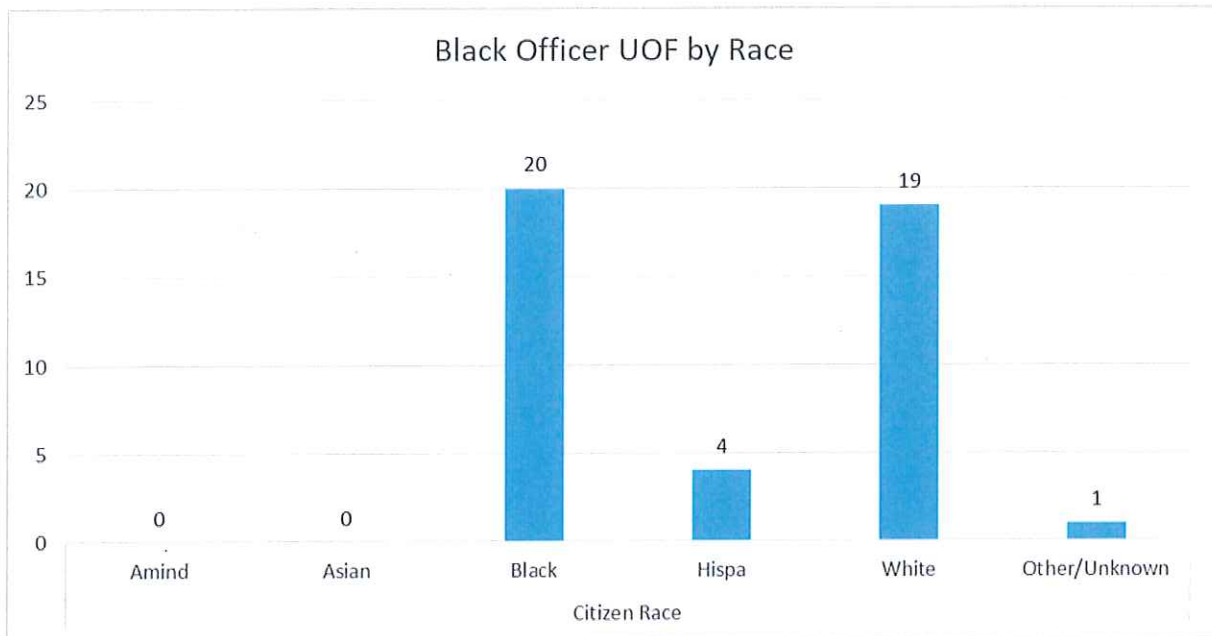

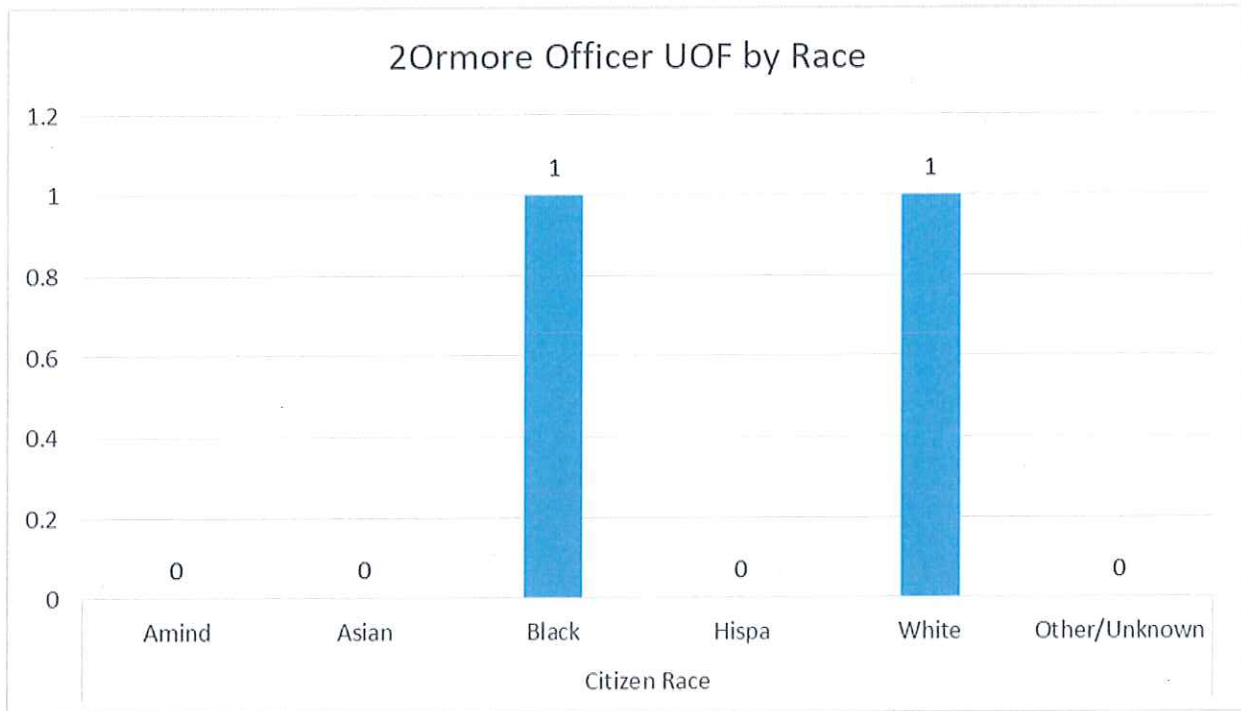
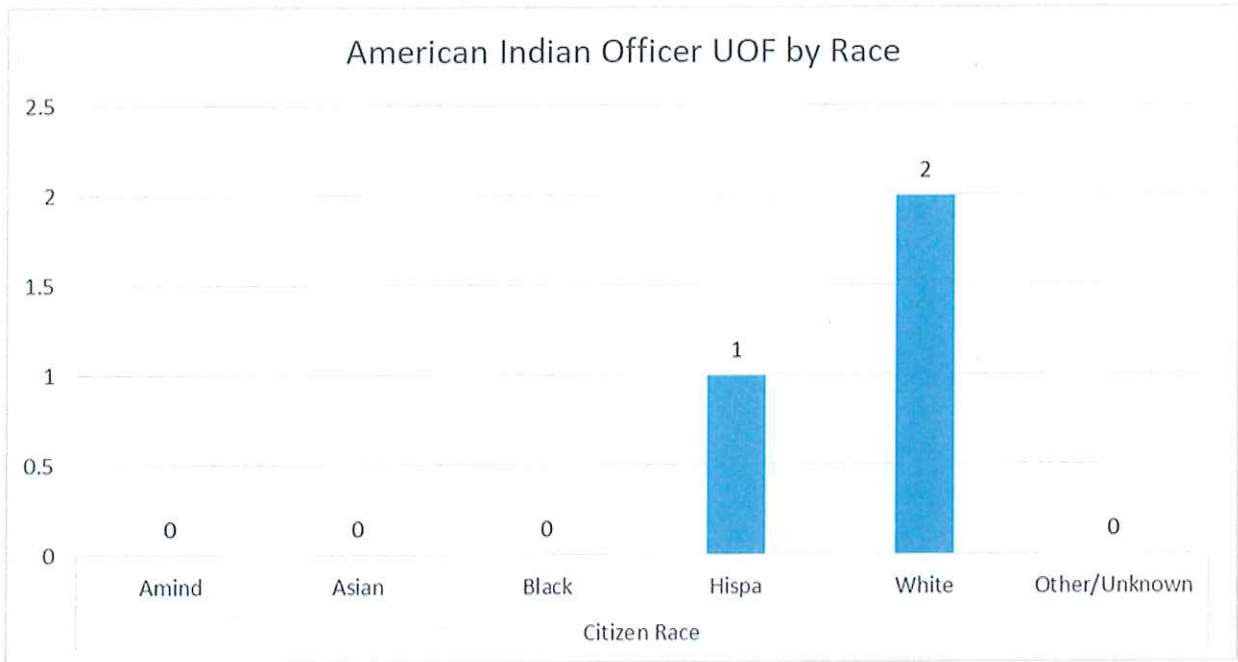
* The *Reasons Leading up to UOF Incidents* chart shows the reason force against a citizen was necessary.



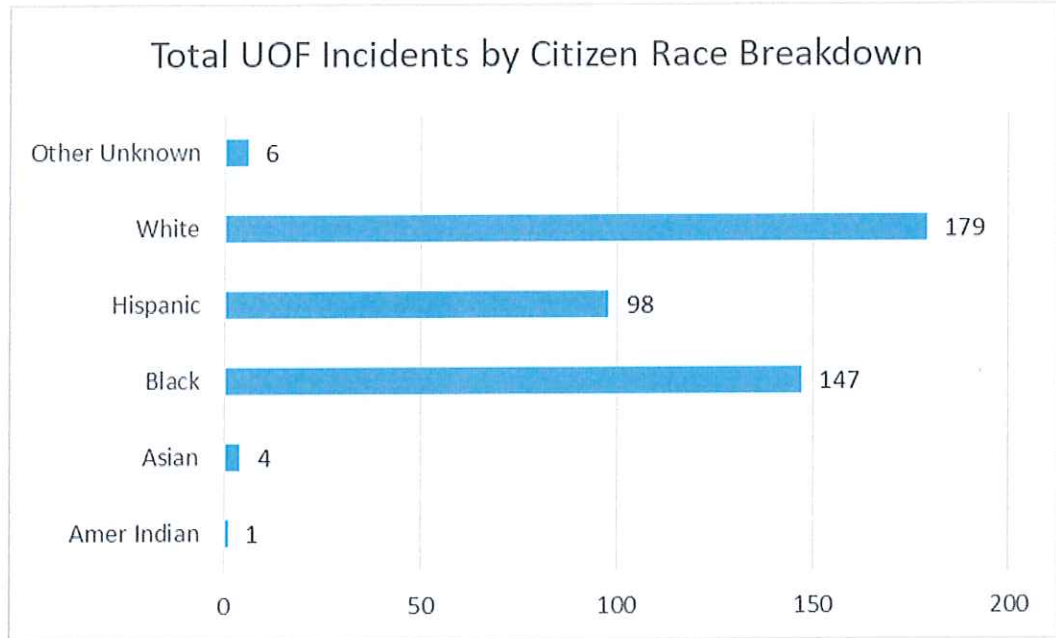

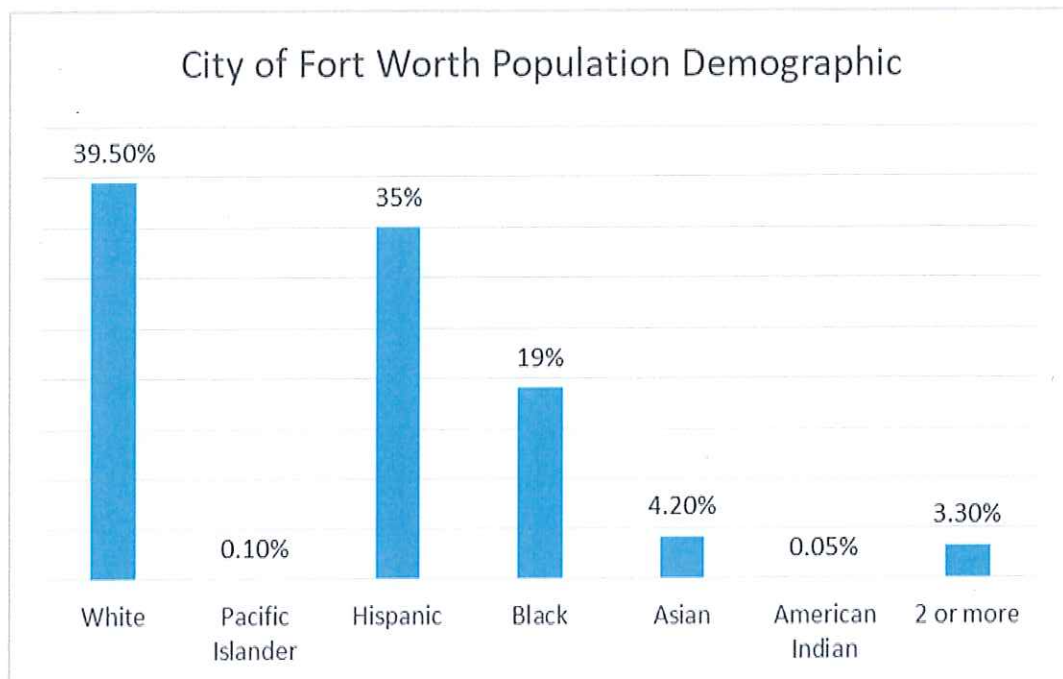




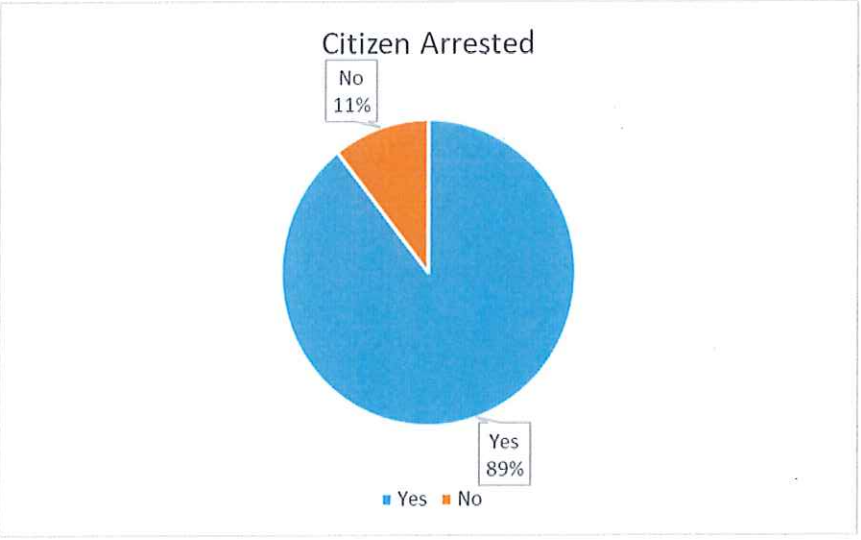
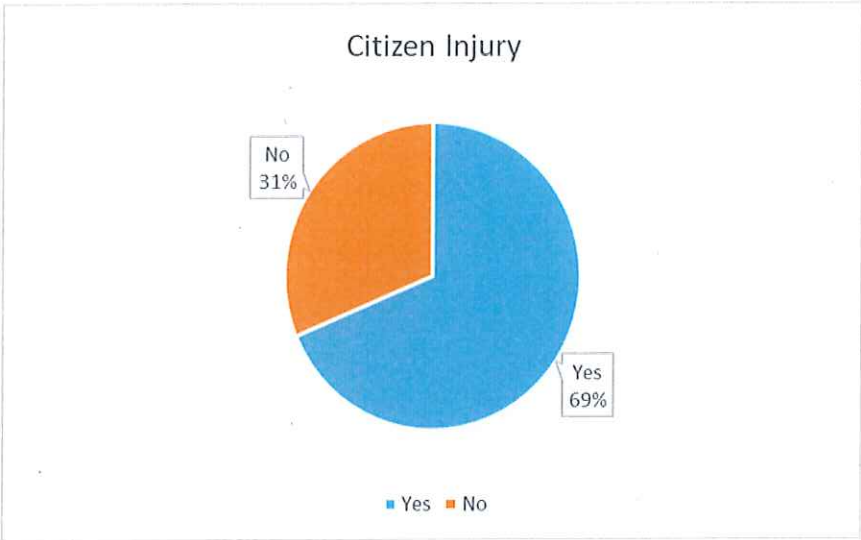
Total Use of Force Incidents by Citizen Race chart is the total number of the citizens involved in a use of force incident broken down by the involved citizen's race.



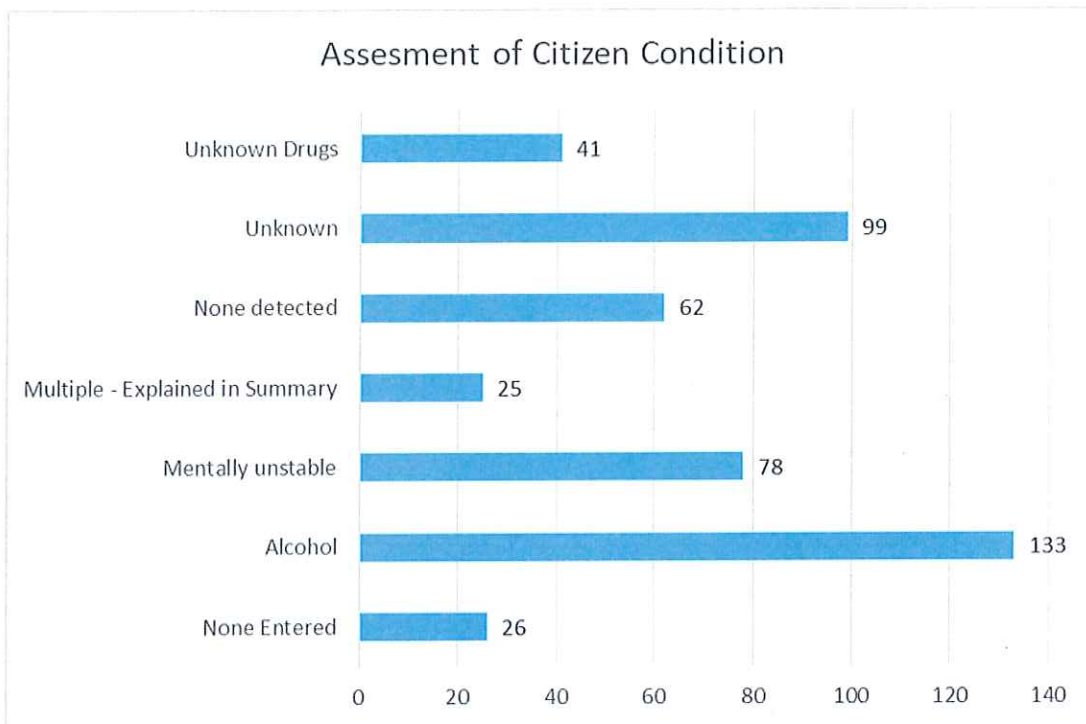
Demographics for the City of Fort Worth based on the 2018 US Census estimate.



Citizen Injury and Arrest charts depict the percentage of time a citizen was arrested and or injured during a Use of Force Incident.

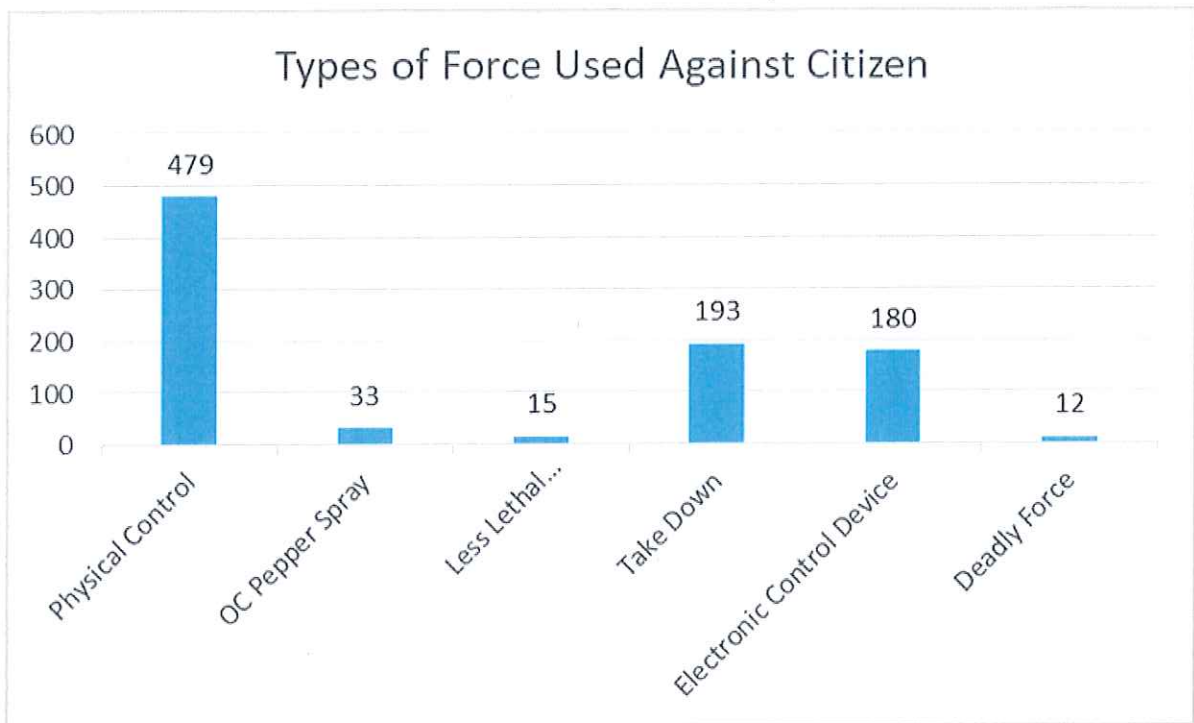

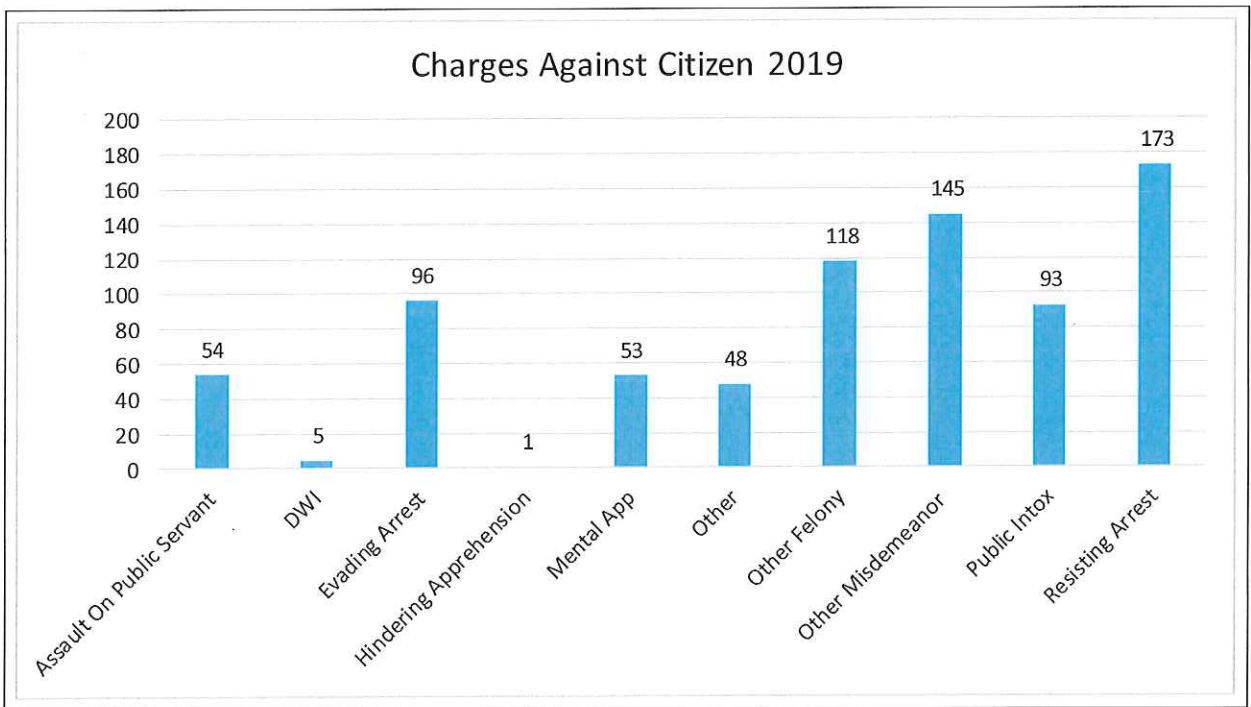

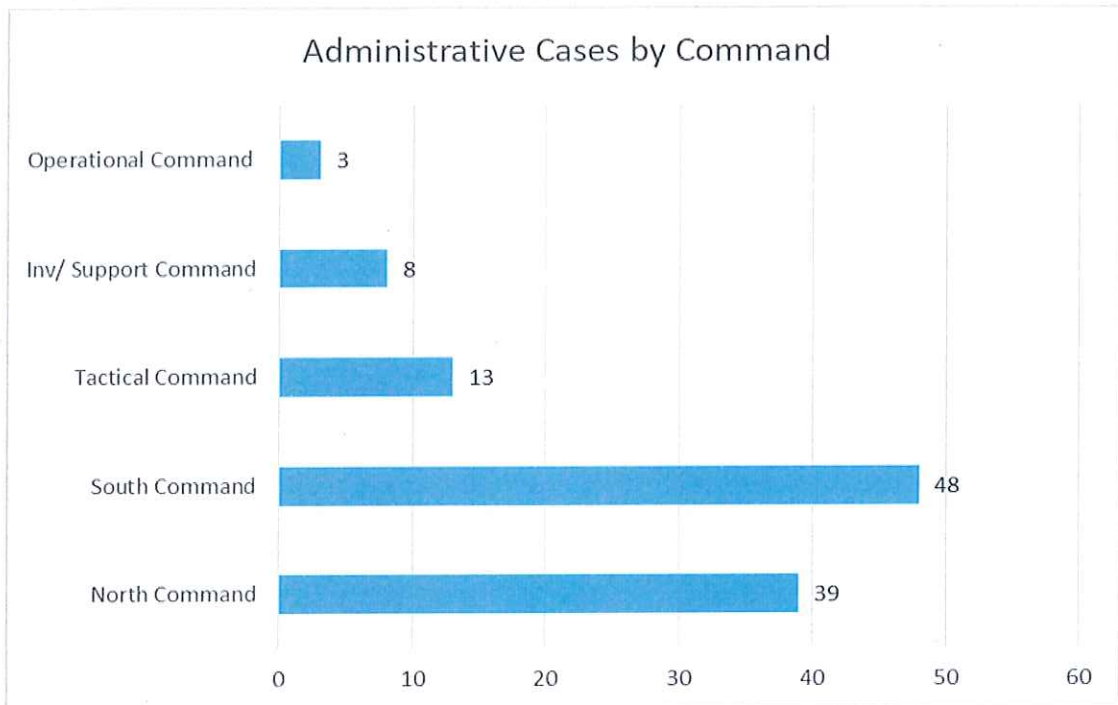




Administrative Cases

- The total number of assigned Administrative Cases for 2019 is 124.
- The total number of minor complaints in 2019 is 245.
- The total number of Administrative Cases pending review and not included is 13.
- The total number of Administrative Cases in 2019 decreased 18% compared to 2018 (153 cases).

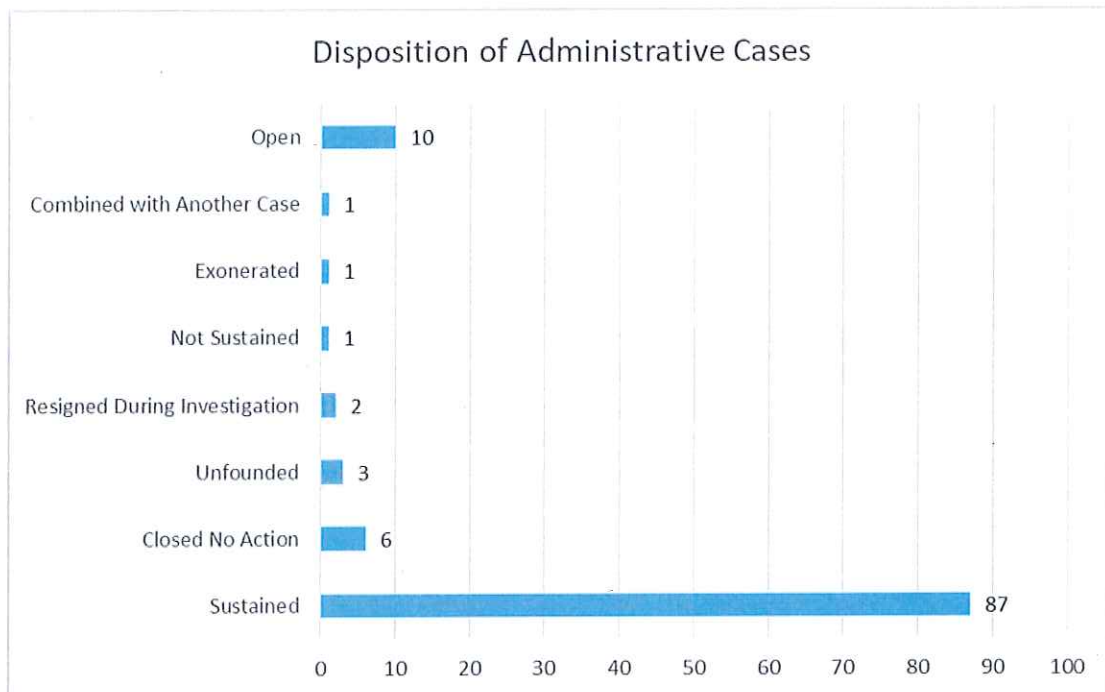
* The *2019 Administrative Cases by Involved Command* chart includes cases that were assigned an IA number and investigated by either Internal Affairs or the Field. This data does not include Vehicle Accidents.



The disposition table and chart below shows the final disposition of administrative cases. As the chart shows, over 78% of the cases had at least one sustained allegation. For comparison purposes, in 2018, 81% of the administrative cases were sustained and in 2017, 65% of the administrative cases were sustained.

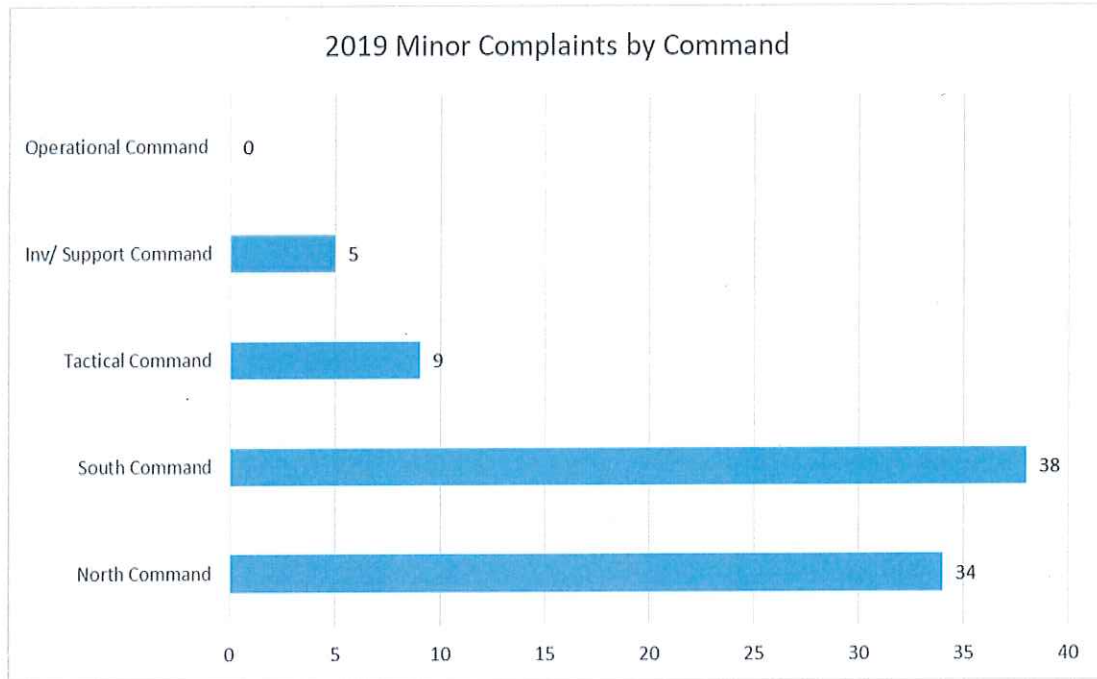

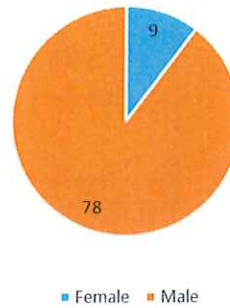
The chart below represents complaints that were forwarded to the respective command for investigation. 9 of the 95 cases were still pending when this report was created so the total below is 86.



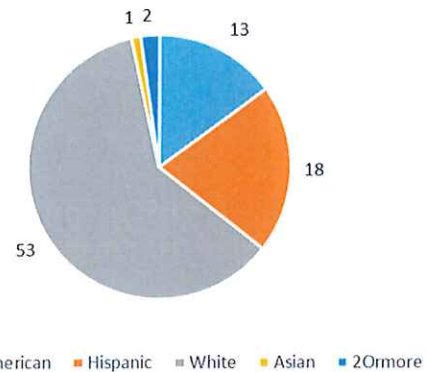

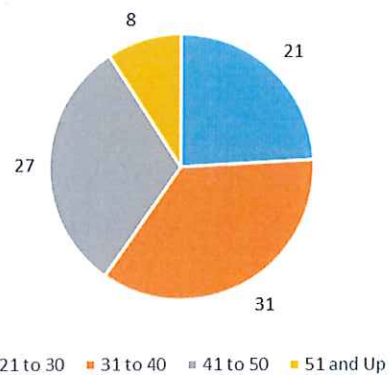
2019 Employees with Sustained Allegations By Gender



2019 Sustained Allegations by Race

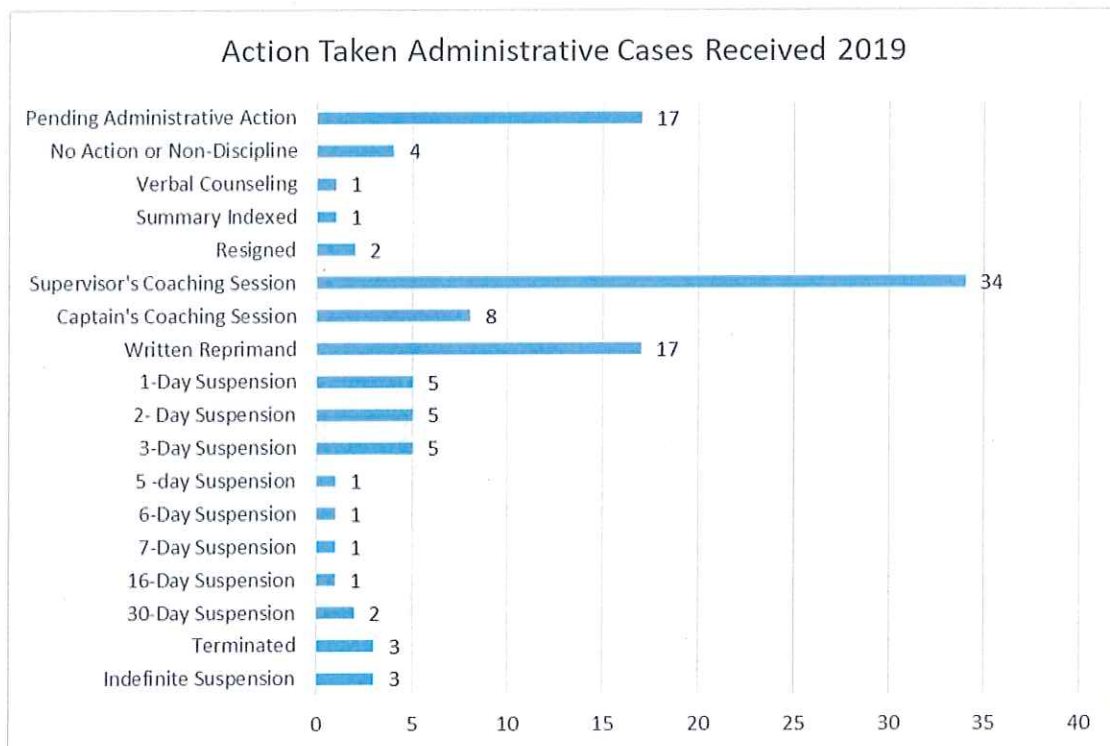


2019 Sustained Allegations by Age Group

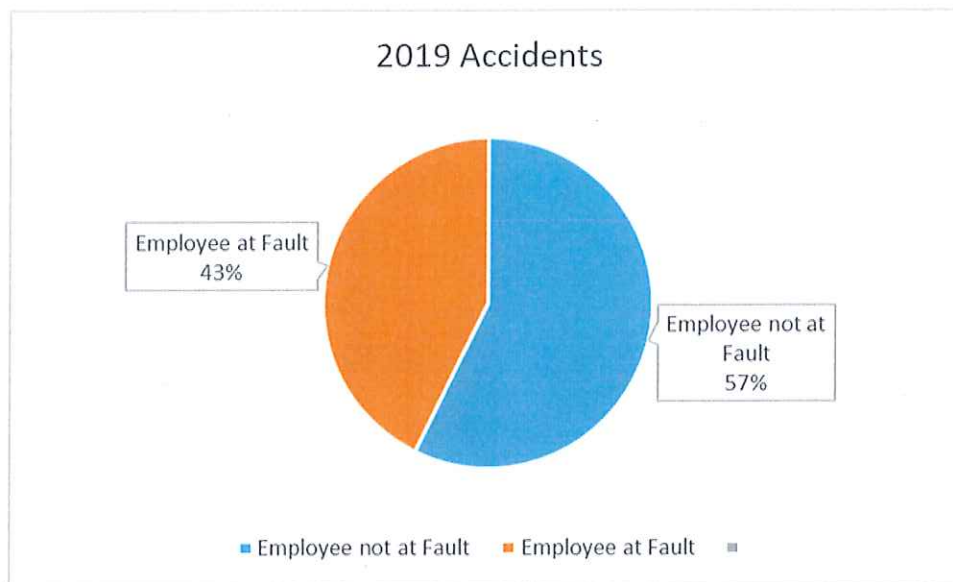

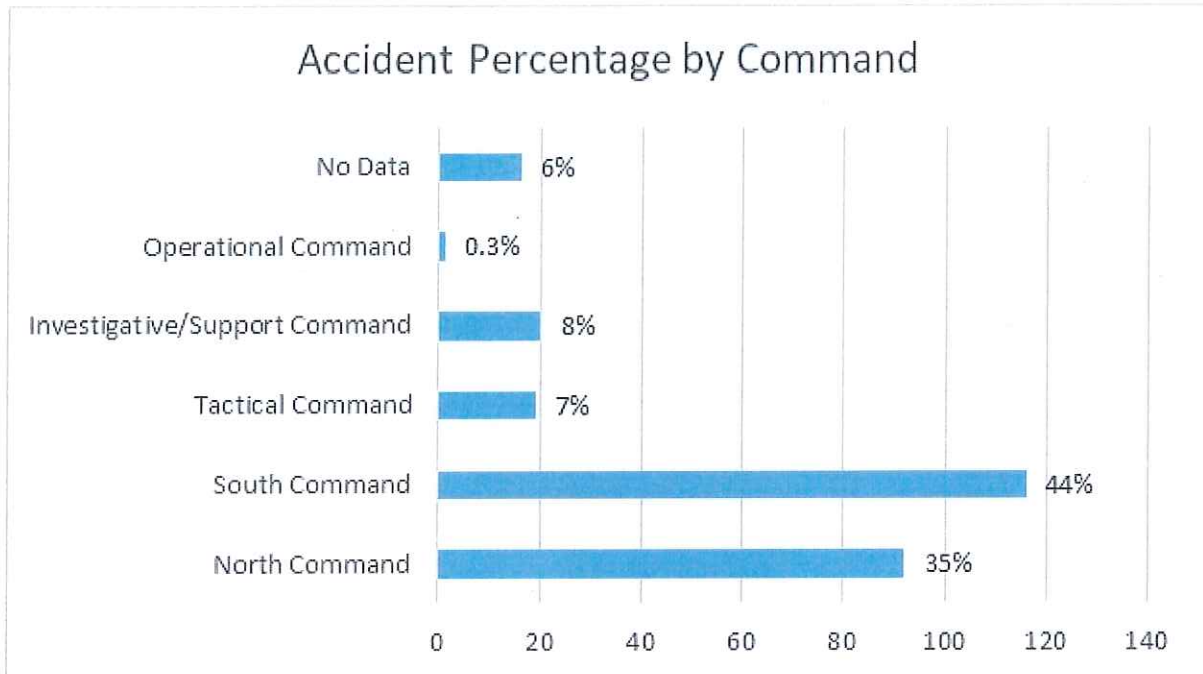


Accidents

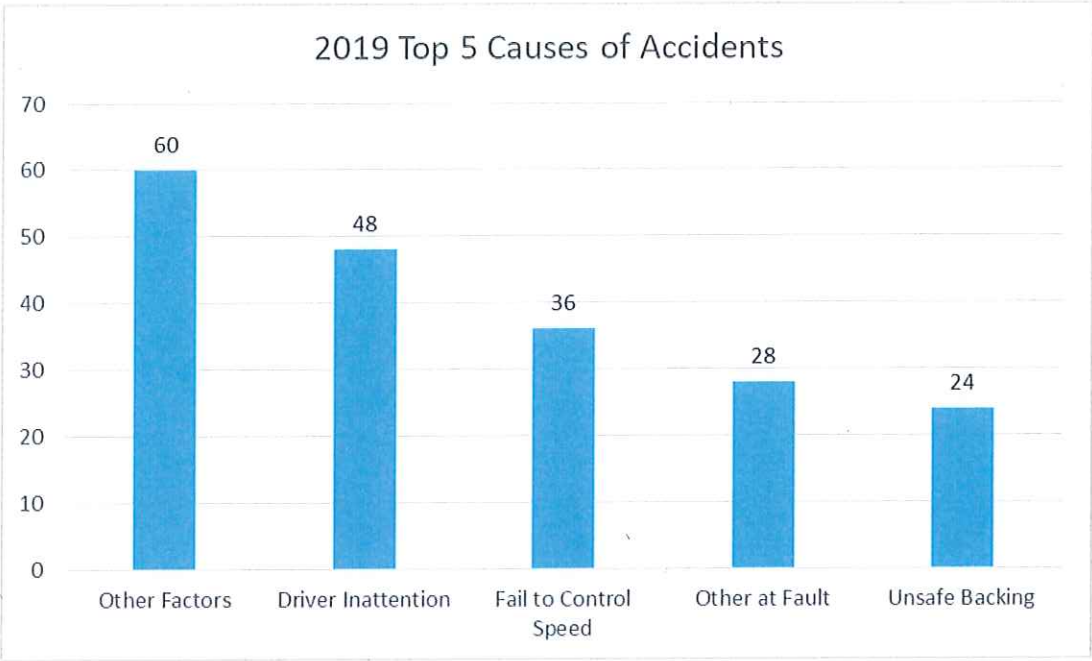
- The total number of Officer Involved Accidents for 2019 is 281.

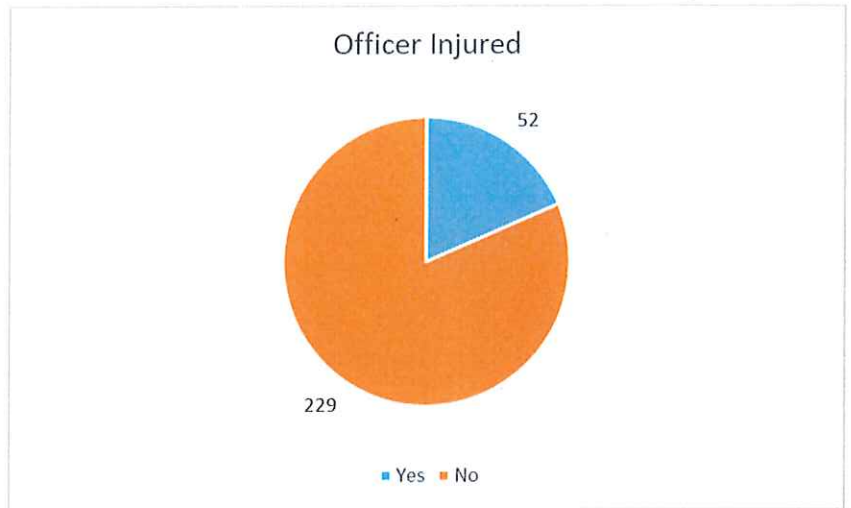


2019 Top 5 Causes of Accidents.

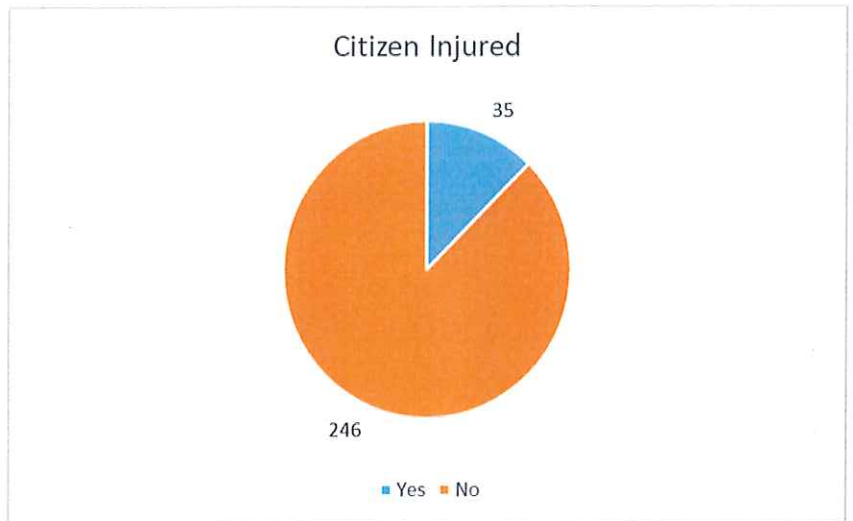


* The **2019 Accident Injuries** chart shows the number of officers and citizens injured during 2019.

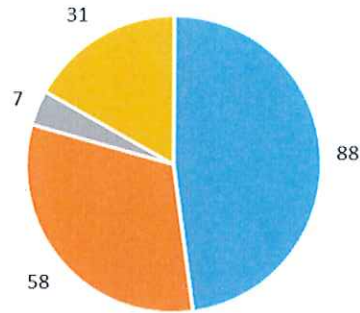


Pursuits

- There were two fatalities associated with a pursuit in 2019.
- 18% of the pursuits were determined to be not justified(34 total).

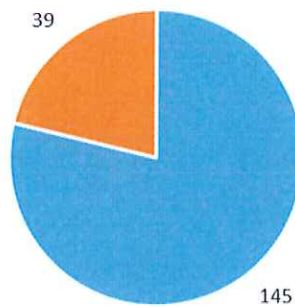

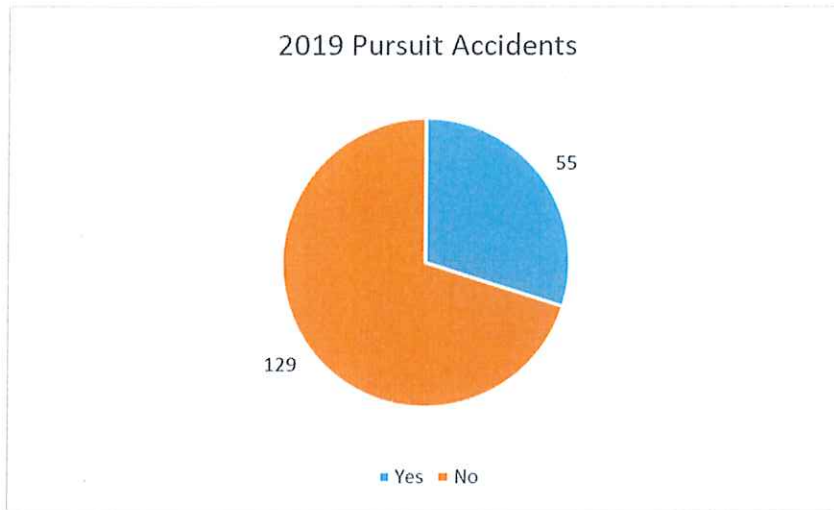
